San Beda University in Brief

San Beda University was established in 1901 as the *El Colegio San Beda* by monks of the Order of St. Benedict, also known as the Benedictines. It was conferred University status by the Philippines' Commission on Higher Education in 2018.


The University offers graduate degree programs in the field of Law, Liturgy, Business, and Medicine, and undergraduate programs in Nursing, Accountancy, Business Administration, Humanities, Arts, Science, and Information Technology, as well as Integrated Basic Education. These programs are taught by a complement of highly qualified and dedicated fulltime and part-time faculty; and administratively supported by engaged and productive non-teaching personnel. As of 2021, the University has a total enrollment of 8,200 in our two campuses located in the City of Manila and in the province of Rizal.

San Beda University is ISO 9001-certified and has PAASCU Level III accredited programs. Its

College of Law has been given the recognition of Excellence in Legal Education; and the Philippine Regulatory Commission has listed our College of Law and the College of Medicine among the top 10 Universities with high passing rates in the licensure examinations in the Philippines.

Locally, the University is a member of the Catholic Educational Association of the Philippines, Philippine Association of Colleges and Universities, Philippine Accrediting Association of Schools, Colleges and Universities, Association of Catholic Universities of the Philippines, and the National Collegiate Athletic Association. Internationally, San Beda University is a member of the ASEAN Learning Network, Association of the Universities of Asia and the Pacific, Association of Southeast and East Asian Catholic Colleges and Universities, Regional Network on Poverty Eradication, Swiss-ASEAN Learning Teaching Networks, and International Commission on Benedictine Education.

San Beda University has endeavored to contribute to the eradication of various diseases and to the promotion of well-being of the Filipino society. The University's impact can be realized not merely through the health education programs it offers, but also through its direct involvement in various community activities, projects, and programs.

Number of Graduates in Health Professions

San Beda University currently offers four-degree programs in health professions: the Doctor of Medicine program, the Bachelor of Science in Psychology program of the College of Arts and Sciences, the Bachelor of Science in Nursing, and the Bachelor of Science in Human Biology.

For academic year 2019-2020, the University had a total of 620 graduates. One hundred fifty-four graduates (25%) were from the health-

related programs. The degree programs have produced graduates who have assimilated themselves into the healthcare system of the country in various capacities, providing the needed manpower to address the healthcare needs of the country.


Current Collaborations with Local, National, or Global Health Institutions on Health and Well-being

San Beda University actively collaborates with various local, national, and global health institutions to improve the health and well-being outcomes of the Philippine society. The collaborative work occurs at different levels of partnership, varying from management of medical illnesses to implementation of health-related interventional and preventive programs.

The University's long standing partnership with the Canossa Health & Social Center in the municipality of Silang, Cavite has resulted in several projects and programs that have benefited the local community over the years. The University, through its medical students and faculty, conducts lectures in the community that tackle various health topics such as nutrition, physical fitness, and prevention of lifestyle diseases. The activities that were undertaken include the vaccination program and feeding program for children.

Health Outreach Programs

San Beda University implements various outreach programs and projects in its partner communities that target several areas related to good health, including hygiene, sanitation, nutrition, infection prevention, lifestyle disease, and hospice/palliative care.

The Water Sanitation and Hygiene (WaSH) program of the College of Medicine began in Silang, Cavite, Philippines in 2016. The aim was to increase awareness on good hygiene and sanitation practices in the BAYANI cluster of barangays (villages), initially starting in Barangay Anahaw II, then expanding to Barangays Narra II and Narra III in 2019.

Activities in the WaSH program included recruitment and training of hygiene educators, as well as house-to-house visits to conduct information and education campaigns on sanitation. In 2018, WaSH in Daycare (WinD) and WaSH in School (WinS) were added to the program. These projects continue up to this day.

In the latter part of 2018, the local officials of Barangay Anahaw II, in partnership with the Canossa Health & Social Center, the San Beda College of Medicine, and the Municipal Sanitary Office of the Municipality of Silang, participated in the Zero Open Defecation (ZOD) program of the Department of Health.

On September 16, 2019, Barangay Anahaw II was awarded a plaque of recognition by the Cavite provincial government for achieving Zero Open Defecation (ZOD) Status - the first barangay to achieve such recognition within the province.


The College of Medicine in collaboration with the Canossa Health and Social Center Foundation, Inc., launched a community-based hypertension control program, Oplan MAHAL (Masusing Alamin, Hypertension ay Lupigin), in May 2019. Free blood pressure monitoring stations were set up in strategic locations of the community and during social events. House-to-house hypertension screening and monitoring were carried out. page houses informational posters and videos for continuing community health education.

The College of Medicine and the Canossa Health and Social Center have been providing community-based comfort care to elderly patients suffering from chronic debilitating diseases and those with terminal illness through the Palliative and Hospice Care Program since 2011. Home visits are conducted by San Beda University medical faculty and students, along with the community health workers, the nuns of the Canossa Order, and the parish priest of the nearby Catholic Church (for spiritual services).


One of the objectives of the RACE project is to establish a pet owners association in the community. The Pet Owners Association (POA) was established on January 31, 2020.

Due to the increasing number of animal bite cases in the BAYANI Cluster barangays, the San Beda University medical students and faculty launched the RACE (Rabies Awareness, Control and Elimination) project in March of 2019 in the community. The project espoused advocacy, Information management and partnership building with the aim of rabies risk reduction through responsible pet ownership.

After the successful launch of the Dengue Awareness campaign in the University campus in 2018, the College of Medicine decided to establish Project BRAD: Bedans Rising Against Dengue in Silang, Cavite in August of 2019. The primary goal of the project is to promote active dengue surveillance, institute rapid community response, and establish local integrated vector management, particularly in Barangay Anahaw II.

Shared Sports Facilities with Local Schools and with the General Public

San Beda University shares the use of its sports facilities for various sports events on a regular basis. In 2019, the University granted the free use of its Gymnasium for hosting the 25th Fr. Martin's Cup Summer League participated by 32 schools; the 16th Uni-Oriental Cup Interscholastic Table Tennis League organized by the Table Tennis for National Development (TATAND) and the Fil-Chi Table Tennis Association with 295 teams participating from across the country; and the San Beda University Alumni Basketball League with 42 SBU alumni batches from 1977 to 2019 competing.



The Father Edgar Martin Basketball Invitational Tournament was established in 1994. The 25th Fr. Martin's Cup Summer League was held from April 7-June 26, 2019 and participated in by 32 teams from various colleges and universities in the Philippines. Most games were played at the San Beda University gym.

Sexual Health Care Programs for Students

The provision of sexual health care in San Beda University consists primarily of information and education services. Most of these are embedded in the curricula and taught to students across colleges as part of their classroom activities. Additionally, students' awareness on sexually transmitted diseases (STD) such as the Human Immunodeficiency Virus (HIV) is promoted through seminars and symposia.

Among these activities, a seminar on “College Adjustment and Mental Wellness” was conducted by the College of Arts and Sciences Guidance and Counseling Office on July 30, 2019, at the New Conference Hall with Ms. Marie Franz A. Gavino, RPsy and Mr. John Paul G. Eugenio, MBA as resource persons. Seven hundred four freshmen attended the program.

Another University activity on Mental Health was a seminar entitled “SILAB: Don’t be Blind to the States of Mind - Breaking the Stigma of Mental Health” held on January 15, 2020, by the San Beda Law - Human Rights Advocates, in coordination with the Guidance Office.



Smoke-Free Policy

San Beda University has an existing No-Smoking Policy that dates to 2002 when the institution was still known as San Beda College. The Rules on Smoking were amended by the Administrators’ Council in a meeting held in October 2002.



The No-Smoking Policy prohibits smoking in all areas of the campus. These rules apply to all administrators, faculty, employees, students, and visitors. The Amended Rules on Smoking specifies the penalties for violations by any individual.



The Student Manuals of the College of Arts and Sciences, College of Nursing, and College of Medicine stipulate that the entire school premises is a smoke-free campus.

SDG 4 – Quality Education

Public Resources for Lifelong Learning

San Beda University, with its firm commitment to lifelong learning, has a free-access policy to its learning resources for individuals not studying in the University, like public high school students, as well as students and faculty from the Mendiola Consortium member-schools. The educational resources of the University Library, the Institutional Media Center, and the Science Laboratories are available to them.

The University Library

The University Library provides free access to comprehensive information resources and services that includes print, multimedia, and online resources such as e-books, e-journals, e-newspapers, and the open-access collection. Resources are available both through the local area network and the University Library official website.



By hosting this Public Lecture Series, the University was able to raise the level of public discourse on issues of national development, justice, and stability. This event held last February 4, 2020, focused on "Combating Climate Change and Its Impact" and was attended by students, faculty, and administrators of other schools, as well as public officials.

In line with the theme of Academic Year 2019-2020, “Pursuit of Peace in Nation Building”, The Republic, a professional organization of the Department of Political Science, in collaboration with the Office of Linkages and International Affairs presented the seminar, Peace Process: Kapayapaan Kaya Pa ‘Yan! (Peace, we can achieve!) on October 23, 2019. This seminar discussed the issues concerning peace and security in the country. Through this event, the public became more aware of the acts that may possibly jeopardize the peace of the country.

The San Beda University Graduate School of Liturgy, together with the National Meeting of Diocesan Directors of Liturgy, the Pontifical Atheneaeum of Saint Anselm, and the Paul VI Institute of Liturgy organized the National Liturgy Conference: Christus Vivit and the Liturgy in General Santos City, Philippines. The conference discussed the implications of Pope Francis’ Apostolic Exhortation “Christus Vivit” on the liturgy, namely the use of contemporary media and Catholic stewardship on the “Good News” amid a changing information culture that distorts human community. Pastoral concerns about online networks’ pitfalls were also emphasized.

Vocational Training Events

In its commitment to provide quality education to those who need it most, San Beda University hosted various vocational education programs open to the public. Computer training for refugees, the Social Enterprise for Economic Development, and seminar livelihood programs are some of these events that directly address the immediate needs of individuals and communities.

San Beda University conducted a training on Basic Microsoft Office on December 12, 2019, at the San Beda University Computer Laboratory for refugees from Iran, Congo, and Cameroon. The training aimed to improve the refugees' computer skills for a better chance of employment, ensuring self-determination and self-reliance.

This activity was part of the University's continuing partnership with the United Nations High Commissioner for Refugees to respond to the needs of refugees. The Community Engagement Center and the College of Arts and Sciences coordinated the activity.

Since 2014, the Office of the Rector-President and the San Beda College Benedictine Educational Foundation Inc. (SBCBEFI) through the Office of Linkages and International Affairs have organized the ASEAN Learning Network (ALN)-San Beda University (SBU) Urban Social Enterprise for Economic Development (SEED) Program. This Program is an ongoing collaborative cross-cultural academic, research, and community engagement-based activity of the Network with its member universities who likewise organize the same Program in their country yearly. Faculty lecturers, students, and staff from Indonesia, Malaysia, Thailand, Vietnam, Philippines, and Switzerland experienced context-based teaching and learning through field immersion in rural and urban communities. ALN-SBU SEED aims to contribute to the transformation of the mindset of the participants and people from the community, the service-learning, social entrepreneurship, and

community engagement strategies to help address the needs and facilitate identification of livelihood opportunities for sustainable development of communities.

In 2019, San Beda University hosted the 2nd Urban SEED Program on August 11-23, 2019, in Antipolo City, Rizal, in collaboration with the San Beda College Benedictine Educational Foundation, Inc., the City Government of Antipolo City and its Barangay Local Government Units. The SEED program was conducted in Barangay Cupang, Barangay San Luis, Barangay San Isidro, Barangay Mayamot, Barangay Dalig, and Barangay Sta. Cruz. A total of 105 households from these barangays were assisted in developing community-based livelihood projects on production and marketing of dishwashing liquid, *lumpia* wrapper, cheese stick, bio-coal, ladle, and chime making.

Education Outreach Activities

San Beda University through the College of Medicine organized the Water and Sanitation Hygiene (WaSH) Program in coordination with the Canossa Health and Social Center, and the BAYANI Cluster of Barangays in Silang, Cavite.

The WaSH program was started in 2016 and aimed to increase the awareness on good hygiene and sanitation practices in the community. Activities included house-to-house information and education campaigns that emphasized the importance of sanitary toilet facilities, and public lectures on the effect of proper waste disposal and its impact on preventing diseases such as diarrhea or acute gastroenteritis.

Lifelong Learning Access Policy

The policy that ensures access to lifelong learning activities regardless of ethnicity, religion, disability, or gender is subsumed in SBU's Vision-Mission Statement, Institutional Objectives, and the Ten Hallmarks of Benedictine Education. This benefits the vulnerable, including persons with disabilities,

indigenous people, and migrants to assure equal opportunity for lifelong learning. Specifically, these are clearly articulated in the following Hallmarks: **Stewardship, Hospitality, and Community.**

Stewardship: We are aware as a community that we are part of a larger ecology and all of environment is a gift of God to be shared by all. We appreciate the good use of material things that will allow us to experience the presence of God and to serve our neighbors. We cultivate creativity in the use of things, especially those limited in supply. *We promote generosity in the sharing of our resources, including time, talent, and treasure.*

Hospitality: We extend a gracious and respectful welcome to people within and outside of our community, particularly the weak, the poor, the marginalized, and those with special needs. We are open to encounter people, especially those different from us and to allow ourselves to be transformed by them. We are open to new ideas and perspectives, races, and cultures, backgrounds, and disposition.

Community: We respect the uniqueness of each individual and at the same time recognize the challenge to serve the common good. We recognize the value of each member as they provide service to the building up of our community, and continuously expand our care and concerns for each of them. We celebrate individual and communal successes and face as a community challenges and failures. We recognize that our community is part of our larger community, including Church and society.

Proportion of First Generation Students

Among the first-year students at the University in Academic Year 2019-2020, 361 were first-generation students, or 15.75%. Of these, 192 students were from the College of Arts and Sciences, 30 students were from the College of Nursing, 84 students were from the College of Law, and 55 students were from the College of Medicine.

There are 2,292 students who enrolled and started their degree at San Beda University in the first semester of AY 2019-2020. Of these, 953 students were from the College of Arts and Sciences, 52 students from the College of Nursing, 232 students from the College of Medicine, 571 students from the College of Law, 293 students from the Graduate School of Law, 25 students from the Graduate School of Liturgy, and 166 students from the Graduate School of Business.

Roque, currently the Dean of the Graduate School of Business and Dr. Ulpiano Sarmiento III, a faculty member of the College of Law.



Policies and Procedures to Identify and Engage with Local Stakeholders



Manual of Operation of the Community Engagement Center

San Beda University is at the forefront in providing meaningful opportunities for community engagements and volunteerism through extension programs that contribute to the human development of partner communities, and their emancipation from various societal ills. The University's engagement with local stakeholders is managed by the Community Engagement Center, an office directly under the Office of the University Rector-President. The Manual of Operation of the Community Engagement Center contains the written policies and procedures to identify and engage with local stakeholders external to the University, such as local residents, local government units, private foundations, and other non-government organizations, among others.

Participatory Bodies for Engagement with Local Residents

The San Beda University Legal Aid Bureau is a clinical legal education program recognized and approved by the Philippine Supreme Court per its February 17, 2004, resolution on Bar Matter No. 963. Since its formal organization in 2004, law student interns, supervised by members of the Faculty of Law and practicing lawyers from the alumni, provide free legal assistance and counseling to clients. When necessary, the Legal Aid Bureau represents indigent court litigants in the prosecution of their cases.

During the First Semester of Academic Year 2019-2020, and prior to the COVID-19 pandemic, the Legal Aid Bureau accepted eight new civil and criminal cases in addition to its list of active pending court cases.



With the onset of the COVID-19 pandemic in March 2020, the government has imposed quarantine restrictions, which resulted to the temporary closure of the Legal Aid Bureau's offices. Undeterred, the Legal Aid Bureau interns launched an online legal forum dubbed as "Tugon sa Bayan, Libreng Payong Ligal" (Public Service, Free Legal Advice). The Legal Aid Bureau has been issuing public advisories, through Facebook posts, on pressing legal issues particularly in relation to the challenges brought about by the pandemic.

Participatory Bodies for Engagement with Local Government

San Bida University has entered partnerships with local governments, through elected political representatives. The partnership with the Office of Congressman Yul Servo Nieto of the Third District, City of Manila, commenced with the opening of a Legal Aid Bureau satellite office at the Office of the Congressman in the Manila City

Hall in October 2019. Legal interns had been providing free legal assistance to the constituents of Congressman Nieto and has conducted seminars on pertinent legal issues.





University Principles on Crime, Corruption, and Bribery


The San Beda University principles against Crime, Corruption, and Bribery are encapsulated in its Vision and Mission Statement. Its commitment to eradicate these societal ills is also made manifest in the statement of the ten Hallmarks of Benedictine Education. These guiding precepts are conspicuously posted in the University website and in all important documents and publications. These are also recited during school programs and other activities to inculcate upon students, faculty, non-teaching personnel, and other stakeholders the necessity of rejecting crime, corruption, and bribery.

Consistent with its Vision and Mission as a Catholic educational institution, San Beda University demands high standards of integrity, discipline, and morality from its employees. In addition to the general grounds for the imposition of disciplinary sanctions on erring

employees under the Labor Code of the Philippines, the Institutional Support Services Personnel Manual of the University categorically defines as serious administrative offenses warranting the supreme penalty of dismissal, the following: (1) Violations related to corruption, extortion, bribery and other forms of dishonest acts; (2) Violations related to fraudulent acts; and (3) Violations related to conflict of interest.





Consistent with its commitment to the Christian formation of its students to become Fully Human, Wholly Christian, Truly Filipino, and Globally Competitive; and aligned with the Benedictine Hallmarks of obedience and discipline, San Beda University prescribes specific rules on faculty and student conduct in or outside of the school campus. 

Academic Freedom Policy







The Philippine Constitution mandates that academic freedom shall be enjoyed in all institutions of higher learning. A recent University Statement reiterates the University's strict adherence to academic freedom by reminding that the Bedan community must safeguard the freedom to study, to research, and to engage in discourse as essential components of university-level education. The university shall exercise academic freedom to determine who should teach, what to teach, how to teach, and who should be taught while maintaining its fidelity to its Vision and Mission. There should be no undue curtailment of academic freedom as this is ultimately a disservice to higher education."

Aligned with the above-stated policy, the Research vision and Faculty Manuals of the different academic units guarantee the academic freedom of teachers in their areas of research and in teaching their research outputs within the limits of law.

Partnership with Government Agencies for Provision of Expert Advice


San Beda University welcomes partnerships with government on areas requiring the expertise of its faculty and administrators. In 2019, the Chairman of the Legal Education Board designated the Dean and the Administrative Officer of the College of Law as members of the Technical Working Group for the crafting of Policies on Deregulation of Law Schools and Allied Law Courses, respectively.

On August 15, 2019, the Dean of the College of Law was also designated as member of the Technical Working Group under the Sub-Committee for Admission to the Bar, which was created by the Supreme Court to study the proposals made at the 2019 National Summit for Legal Education on the revision of the Bar Examination coverage and the Law curriculum.


In February 2018, the University entered into a Memorandum of Agreement with the Department of Social Welfare and Development-National Capital Region. Under the Agreement, which was effective until December 2020, the school was obliged to provide the government agency programs and services such as health intervention, capacity building, legal and psychological counselling, values formation, and empowerment programs to improve the beneficiaries' level of well-being. The school also committed to provide the mechanism for extending technical assistance such as facilitation of Family Development sessions, coaching or mentoring of parent leaders, improvement of teaching and training materials, and livelihood and entrepreneurial training and provision of business development services to beneficiaries.




Participation in Government Research




3-Year Learning and Development Plan for the House of Representatives prepared by the Vice President for Academics of San Beda University







Graduates of Law and Civil Enforcement

San Beda University contributes professionals in Law and Civil enforcement. In Academic year 2019-2020, 183 students successfully earned their Juris Doctor degree. The Bachelor of Science in Legal Management was offered as one of the undergraduate courses in the College of Arts and Sciences in 2003. In Academic year 2019-2020, 20 students successfully earned their bachelor's degree in Legal Management. In the same period, 18 students successfully earned their Master of Laws or Doctor of Juridical Science degrees. San Beda University produced a total of 620 graduates across all courses. Of the total number of graduates, 221 representing 35.65 % are graduates of law and enforcement related courses.

A total of 105 households from six SEED urban communities in Antipolo, Rizal benefitted from the business plans prepared by the forty-three local and international Urban SEED participants from Indonesia, Malaysia, Thailand, Vietnam, Switzerland, and the Philippines. The business plans present detailed community-based livelihood projects on production and marketing of dishwashing liquid, *lumpia* wrapper, cheese stick, bio-coal, ladle, and chime making.

Summer Program for Social Entrepreneurship for Economic Development held in Dong Thap, Vietnam

San Beda University participated in the 2019 Summer Program for Social Entrepreneurship for Economic Development. This activity is a cross-cultural project of the Swiss-ASEAN Learning and Teaching Association, University of Applied Sciences and Arts Northwestern Switzerland and the University of Economics of Ho Chi Minh City, Vietnam. Collaboration with NGOs for SDGs

Aiding the Prison Detainees

San Beda University's Community Engagement Center and the San Beda University Junior Bedan Law Circle in partnership with the Humanitarian Legal Assistance Foundation, Inc. provided legal assistance to detainees through the *Lingkod Laya* (Help for Freedom) Program.

The program commenced in 2018 and continued in 2019 and 2020. These efforts had helped in securing the immediate release of detainees who are already eligible but have remained in jail custody because of the failure to accomplish procedural requirements.

The ongoing programs are WaSH in Daycare (WinD) and WaSH in School (WinS) in partnership with Bagong Buhay Elementary School and Bulihan Sites and Services Project Elementary School.


Tutoring Public High School Students
